Executive Committee Initiatives

- 1. Develop a repeatable method for developing and following our strategic plan
 - Rennovate the approach to developing our strategic plan
 - Initiated EC strategic planning with all officers involved (Jan 2014)
 - Modified the Officer's meetings in 2014 to significantly incorporate strategic planning
 - Clearly identify what we want to see and when
 - Provided strategic planning templates outlining a consistent format across the committees with examples and dates for statusing
 - Requested specific responses and input with respect to the written Word document
- 2. Involve the executive leadership in the development, implementation, and status of the strategic plan
 - Requested the Officers each lead the development activity for their area
 - Requested that the officers track, update, and status their plans regularly with the entire EC
- 3. Improve EC communication in general
 - Would like to hold monthly telecoms (like magazine) starting in Feb (for any issues, not just for Strat Plan
 - Use email and/or IEEE collaboration tools for items that can't wait a month
 - If e-mail is used to communicate issues, include time limits such as 2 weeks before resorting to collaboration tools or monthly meeting

EC SP Metrics/Scorecard

- 1. Develop a repeatable method for developing and following our strategic plan
 - Renovated 75% of the approach to developing our strategic plan
 - Still need to determine how this is reflected in written plan
 - Clearly identify what we want to see and when
 - At least 85% of officers provided verbal presentations
 - Less than 10% provided feedback on written plan
 - Society behind 1 year in providing written plan to IEEE for 2014-2015
 - -Teresa 100% responsible
 - Contributing factors could be new approach, lack of understanding timeline, etc (are the strat plan procedures identified somewhere I missed?)
 - Must submit plan asap and ensure delay does not happen in future
- 2. Involve the executive leadership in the development, implementation, and status of the strategic plan
 - 85% avg officer attendance at strat plan meetings
 - Statistics not yet available. As of today officers are working on tracking, updating, and statusing their plans regularly with the entire EC reviewing twice a year
 - Does this seem to be working
- 3. Improve EC communication in general
 - TBD initiatives have not yet been implemented
